Situated in the State of Ohio, County of Franklin, City of Columbus, lying in Quarter Township 4, Township 2 North, Range 18 West, of the United-States Military Lands, and being part of a 1.622 acre tract conveyed to BL&G, LLC, an Ohio limited liability company (hereinafter referred to as "Grantor") by deed of record in Instrument Number 201401140005430 (Franklin County Parcel Number 010-143756-00) (all documents referenced herein are from the Franklin County Recorder's Office), and being more particularly described as follows:

BEGIN FOR REFERENCE at the intersection of the centerline right-of-way of East Dublin Granville Road (SR 161) (FRA-161-11.57) (width varies), centerline station 690+25.39 and center line of right-of-way of Parkville Street as dedicated in Plat Book 41, Page 51, (width varies), centerline station 131+46.60, being referenced by a found iron pin in concrete at East Dublin Granville Road (SR 161) centerline station 695+00.18, which bears South 75° 19' 01" East a distance of 474.79 feet;

Thence the following two (2) courses and distances along the centerline of right-of-way of Parkville Street;

- 1. South 14° 44' 33" West a distance of 266.99 feet to a 1 inch steel rod set at centerline station 128+79.61;
- 2. Along a curve to the left with a radius of 840.08 feet, a delta angle of 11° 07' 45", an arc length of 163.18 feet, a chord bearing of South 09° 10' 39" West and with chord distance of 162.92 feet to 1 inch steel rod set at centerline station 127+16.43 ahead, 27+16.43 back;

Thence South 86° 27' 46" East a distance of 30.00 feet leaving the centerline and crossing Parkville Street to a 3/4 inch iron pipe found on the easterly right-of-way line at the southwest corner of said 1.622 acre tract and the northwest corner of a 5.787 acre tract conveyed to

Thence South 75° 18' 24" East a distance of 16.40 feet along the line common to the Grantor and the 1.622 acre tract to a point, 46.00 feet right of centerline station 27+13.27 and the **TRUE POINT OF BEGINNING** for the temporary easement herein described;

Thence leaving the line common to the Grantor and said 5.787 acre tract the following five (5) courses across the Grantor's 1.622 acre tract;

- 1. North 38° 59' 14" East a distance of 8.12 feet to a 5/8 inch rebar set with cap stamped "DLZ OHIO INC.", 50.78 feet right of centerline station 127+20.16;
- Along a curve to the right with a radius of 89.00 feet, a delta angle of 06° 43' 59", an arc length of 10.46 feet, a chord bearing North 42° 21' 13" East and with a chord distance of 10.45 feet to a 5/8 inch rebar set with cap stamped "DLZ OHIO INC." at a point of reverse curvature, 57.24 feet right of centerline station 127+28.94;

Along a curve to the left with a radius of 56.00 feet, a delta angle of 62° 11' 58", an arc length of 60.79 feet, a chord bearing North 14° 37' 13" East and with a chord distance of 57.85 feet to a 5/8 inch rebar set with cap stamped "DLZ OHIO INC." at a point of tangency, 65.35 feet right of centerline station 127+90.75;
- North 16° 28' 45" West a distance of 40.47 feet to a 5/8 inch rebar, 30 inches long, with yellow cap stamped "DLZ OHIO INC." set, 47.29 feet right of centerline station 128+29.58;
- 5. Along a curve to the right with a radius of 129.13 feet, a delta angle of 31° 09' 34", an arc length of 70.22 feet, a chord bearing North 00° 53' 29" West and with a chord distance of 69.36 feet to a 5/8 inch rebar set with cap stamped "DLZ OHIO INC.", on the easterly right-of-way line of Parkville Street, 30.00 feet right of centerline station 128+99.22;

Thence North 14° 45' 56" East a distance of 74.85 feet along the easterly right-of-way line of Parkville Street and the Grantor's westerly line to a 5/8 inch rebar set with cap stamped "DLZ OHIO INC.", on the southerly right-of-way line of East Dublin Granville Road (S.R. 161) (FRA-161-11.57) and the Grantor's northerly line 30.04 feet right of centerline station 129+74.07;

Thence North 55° 35' 54" East a distance of 29.75 feet along the southerly right-of-way line of East Dublin Granville Road (S.R. 161) (FRA-161-11.57) and the Grantor's northerly line to a 5/8 inch rebar set with cap stamped "DLZ OHIO INC.", 49.50 feet right of centerline station 129+96.57;

Thence South 78° 05' 51" East a distance of 15.49 feet along the southerly right-of-way line of East Dublin Granville Road (S.R. 161) (FRA-161-11.57) and the Grantor's northerly line to a point, 64.97 feet right of centerline station 129+97.34;

Thence leaving the southerly right-of-way line of East Dublin Granville Road (S.R. 161) (FRA-161-11.57) and the Grantor's northerly line the following five (5) courses across the Grantor's 1.622 acre tract;

- 1. South 59° 22' 30" West a distance of 29.89 feet to a point, 43.97 feet right of centerline station 129+76.06;
- 2. South 09° 52' 20" West a distance of 113.24 feet to a point, 53.42 feet right of centerline station 128+62.12;
- 3. South 06° 28' 56" West a distance of 37.20 feet to a point, 57.12 feet right of centerline station 128+22.49;
- 4. South 78° 06" 19" East a distance of 54.33 feet to a point, 111.44 feet right of centerline station 128+21.35;
- 5. South 12° 34' 29" West a distance of 105.85 feet to a point on the line common to the Grantor and said 5.787 acre tract, 100.61 feet right of centerline station 27+02.50;

Thence North 75° 18' 24" West a distance of 55.58 feet along the line common to the Grantor and said 5.787 acre tract, to the **TRUE POINT OF BEGINNING**, containing 0.175 acres, more or less, being subject to all easements, restrictions, and rights-of-way of record.
