Thence along the westerly line of Lot 80, and the easterly right-of-way line of Worthington Woods Boulevard, along a curve to the right having a Delta Angle of 07 degrees 03 minutes 22 seconds, a Radius of 710.00 feet, an Arc Length of 87.44 feet, along a Chord Bearing **North 12 degrees 29 minutes 11 seconds East, 87.38 feet** to the northwest corner of Lot 80 and the southwest corner of Lot 79, being 40.00 feet Right of Station 76+01.75 of the Centerline of Right-of-Way of Worthington Woods Boulevard;

Thence along the northerly line of Lot 80 and the southerly line of Lot 79, **South 73 degrees 59 minutes 08 seconds East, 1.75 feet** to a point 41.75 feet Right of Station 76+01.75 of the Centerline of Right-of-Way of Worthington Woods Boulevard;

Thence crossing Lot 80, along a curve to the left having a Delta Angle of 07 degrees 03 minutes 22 seconds, a Radius of 708.25 feet, an Arc Length of 87.22 feet, along a Chord Bearing **South 12 degrees 29 minutes 11 seconds West, 87.17 feet** to the southerly line of Lot 80 and the northerly line of Lot 81, being 41.75 feet Right of Station 75+09.39 of the Centerline of Right-of-Way of Worthington Woods Boulevard;

Thence along the southerly line of Lot 80 and the northerly line of Lot 81, **North 81 degrees 02 minutes 30 seconds West, 1.75 feet** to the TRUE POINT OF BEGINNING, containing 0.0035 acre (153 Square Feet), more or less, all of which is contained within Franklin County Auditor's Parcel Number 610-197832-00.
