Thence South 85° 53' 11" East, with said southerly right-of-way line, a distance of 575.15 feet to the northeasterly corner of said Lot 94 and the northwesterly corner of Lot 95 of said "American Addition";

The centerline of Joyce Avenue, having a bearing of North 04° 07' 58" East, is designated the "basis of bearing" for this description.
