The following investigation was conducted concerning the City of Columbus' 2022 annual objection to the renewal of liquor permit 9078365 issued to 2635 Broad LLC, which is doing business as Mobile Mart, located at 2635 West Broad Street, Columbus, Ohio 43204. The record owner of said permit is Shaheen Akhtar.

The City of Columbus has also objected to a permit transfer request at this location, new permit number **6072630**, requesting party, **Mobil 2635 Broad Inc.**, requesting to do business as **Mobil** at the same location. The record owners of this entity requesting the permit transfer are **Ziad Hijazin** and **Laith Banekhlid**.

After reviewing the State of Ohio, Franklin County, and City of Columbus records regarding the above liquor permit establishment, the following information has been compiled to support the objection to the renewal of the aforementioned permit issued by the State of Ohio.

The above listed liquor establishment has been issued **C1** and **C2** permits by the Division of Liquor. This permit grants the permit holder the privilege to sell alcoholic beverages at the above listed address.

An inquiry of liquor and Ohio Investigative Unit violations revealed that the permit holder has received the following violations in **2021 and 2022**:
