The following investigation was conducted concerning the City of Columbus' 2022 annual objection to the renewal of liquor permit 84189942450 issued to Speedway LLC, which is doing business as Speedway 9706, located at 3304 East Broad Street, Columbus, Ohio 43213. The Division of Liquor Control does not list an individual owner of this permit.

After reviewing the State of Ohio, Franklin County, and City of Columbus records regarding the above liquor permit establishment, the following information has been compiled to support the objection to the renewal of the aforementioned permit issued by the State of Ohio.

The above listed liquor establishment has been issued **C1** and **C2** permits by the Division of Liquor. This permit grants the permit holder the privilege to sell alcoholic beverages at the above listed address.

An inquiry of Ohio Investigative Unit violations revealed that the permit holder has received the following violations in **2022**:

In addition, the Columbus Division of Police and Division of Fire have been dispatched to **3304 East Broad Street, Columbus, Ohio 43213** on **six hundred eighty-one (681)** calls for service, **four hundred thirteen (413)** in 2021, and **two hundred sixty-eight (268)** in 2022 at **Speedway** (totals minus calls attributed to CPD special duty officers). These calls for service include responses to robberies, shots fired, persons with a gun, persons with a knife, intoxicated persons needing assistance, narcotics complaints, OVIs, overdoses, assaults, fights, domestic violence, disturbances, indecent exposure, burglary, persons with outstanding warrants, and motor vehicle thefts. CFD specifically responded to **seven (7)** overdoses at the Premises.
