Situated in the State of Ohio, City of Columbus, Franklin County, Quarter Township No. 3, Township 1, Range 17, U.S. Military Lands and being part of Lots 470 and 471 in the C.E. Morris Trustee, ETAL., East Columbus Addition recorded in Plat Book 5, page 364-366 and conveyed to Wedgewood Sullivant Investments, LLC., an Ohio Limited Liability Company, in Instrument 200506030107545 in the Franklin County Recorder's Office. The below described parcel laying on the left side of the proposed centerline of right of way for 5th Avenue in project FRA-C.R. 96-1.71. (Cassady Ave.) as platted by 2LMN, Inc. and recorded in Instrument 202109170166308, being Plat Book 131, Page 66, and being more particularly described as follows:

COMMENCING at a point at the southwest corner of Lot 471, said point being 29.73 feet left of the centerline of proposed right of way and construction for 5th Avenue at station 208+59.73 and being the **TRUE POINT OF BEGINNING** for the parcel herein described:

- 1) **Thence**, along the west line of said Lot 471, **North 02 degrees 24 minutes 35 seconds East, 4.77 feet** to a point, said point being 34.50 feet left of the centerline of proposed right of way and construction for 5th Avenue at station 208+59.65;
- 2) **Thence**, across said Lots 471 and 470, **South 86 degrees 35 minutes 42 seconds East, 65.95 feet** to a point on the east line of said Lot 470 and the west line of Lot 469, said point being 33.97 feet left of the centerline of proposed right of way and construction for 5th Avenue at station 209+26.01;
- 3) **Thence**, along the east line of said Lot 470 and the west line of said Lot 469, **South 02 degrees 24 minutes 35 seconds West, 3.97 feet** to a point on the southeasterly corner of said Lot 470 and being on the northerly existing right of way for 5th Avenue, said point being 30.00 feet left of the centerline of proposed right of way and construction for 5th Avenue at station 209+26.04;

- 4) **Thence**, along the south line of said Lot 470 and 471 and the northerly existing right of way for 5th Avenue, **North 87 degrees 17 minutes 04 seconds West, 65.94 feet** to the **TRUE POINT OF BEGINNING**, containing 0.007 acres.

The parcel of land described contains, 0.007 acres, more or less is located in Franklin County Auditor's Parcel Number 010-010080-00 including the present road occupies 0.000 acres, more or less.

All irons pins set are 5/8 inch x 30 inch rebar with a 1 inch plastic cap stamped "2LMN, Inc".

The bearings shown hereon are based on the centerline of Cassady Avenue from Margaret Street to East 7th Avenue as being North 09 degrees 35 minutes 04 seconds East, from an adjusted field survey using GPS methods from the nearby City of Columbus monument (COC32-82), nearby United States Geological Survey monument (802.52USGS), and Continually Operating Reference Station (CORS) COLB, based on the Ohio State Plane Coordinate System, South Zone, and North American Datum 1983 (NSRS 2007) scaled to ground by 1.000042617 about the projection origin (0,0).
