[Surveyor's description of the premises follows]

Situated in the State of Ohio, City of Columbus, Franklin County, Quarter Township 4, Township 1, Range 18, U.S. Military Lands and being parts of Lot 196, of Indianola Park View Addition as recorded in Plat Book 9, page 1-B and conveyed to Ryan Robert Craig and Caitlan B. Craig in Instrument 2022010040002150 in the Franklin County Recorder's Office. The below described parcel laying on the south side of Arcadia Avenue, and being more particularly described as follows:

COMMENCING at an 8 inch mag nail set at the intersection of Right of Ways for the south side of a 20 foot alley as dedicated in said Plat Book 9, Page 1-B, and the east side of Fourth Street (100'R/W), being the northwest corner of said Lot 196, Thence, along said south Right of Way of said 20 foot alley, South 86 degrees 48 minutes 24 seconds East, 1.78 feet, said iron pin set being the **TRUE POINT OF BEGINNING** for the parcel herein described:

- 1) **Thence**, along the grantor's north line and the south existing Right of Way of said 20 foot alley, **South 86 degrees 48 minutes 24 seconds East, 3.02 feet** to a point;
- 2) **Thence**, across the grantor's tract, **South 02 degrees 28 minutes 08 seconds East, 19.84 feet** to a point;
- 3) **Thence**, across the grantor's tract, **South 87 degrees 31 minutes 52 seconds West, 2.59 feet** to a point on the existing Right of Way line for Fourth Street (100'R/W);
- 4) **Thence**, along the grantor's west line and the east existing Right of Way line for Fourth Street (100'R/W), with a curve to the right having a radius of 50.00, a central angle of 14 degrees 56 minutes 35 seconds, an arc length of 13.04 feet and a chord that bears, **North 04 degrees 16 minutes 42 seconds West, 13.00 feet** to an iron pin set;
- 5) **Thence**, across the grantor's tract, **North 02 degrees 28 minutes 08 seconds West, 7.14 feet** to the **TRUE POINT OF BEGINNING**, containing 0.001 acres.
