Situated in the State of Ohio, County of Franklin, City of Columbus, and being located in Section 1, Township 11 North, Range 21 West, Congress Lands, and being out of that 6.005 acre tract of land described in a deed to **T & R Gender, LLC**, of record in Instrument Number 200709280170419, of the Franklin County Deed Records, Auditor's Parcel number 530-125542 and more particularly described as follows:

Beginning at a 3/4"x 36" Iron Pin with a 3" aluminum cap in a standard ODOT monument box to be set in the pavement at the intersection of the centerline construction of Refugee Road, and centerline construction of Gender Road, being STA 112+30.93 Refugee Road and equaling STA 216+59.94 Gender Road, as shown on the Centerline Plat of FRA-222 (Gender Road) and recorded in Plat Book 117, Page 72, of the Plat Records of Franklin County;

Thence along the said centerline construction of Refugee Road, South 77° 34' 14" East, 325.19 feet to a point being at centerline construction STA 115+56.13;

Thence leaving said centerline construction of Refugee Road, South 12° 25' 46" West, 45.19 feet, to a point being on the existing south right of way line of Refugee Road as conveyed to the City of Columbus, of record in Official Record Volume 10744, Page I15, of the Franklin County Deed Records, also being on the westerly property line of said 6.005 acre tract also being an easterly property line of a 1.226 acre tract of land as conveyed to Brauvn Net Lease, LLC, in Instrument Number 201101100005258 of the Franklin County Deed Records, being at centerline construction STA 115+56.13, 45.19 feet RT. said point being the **True Point of Beginning** for the parcel herein described;

Thence along the said existing south right of way line of Refugee Road as conveyed to the City of Columbus, of record in Official Record Volume 10744, Page I15, of the Franklin County Deed Records, South 82° 55' 42" East, 31.43 feet to a point being the southwest corner of the right of way of Refugee Road as conveyed to the City of Columbus, of record in Official Record Volume 29876, Page B15, of the Franklin County Deed Records, being at centerline construction STA 115+87.42, 42.26 feet RT;

Thence along the existing south right of way line of Refugee Road as conveyed to the City of Columbus, of record in Official Record Volume 29876, Page B15, of the Franklin County Deed Records, South 70° 51' 39" East, 44.86 feet to an Iron Pin Set being at centerline construction STA 116+31.97, 47.50 feet RT;

Thence crossing through said grantor's 6.005 acre tract, North 77° 34' 14" West, 75.52 feet to an Iron Pin Set being on the said westerly property line of the 6.005 acre tract also being the said easterly property line of the 1.226 acre tract being at centerline construction STA 115+56.45, 47.50 feet RT;

Thence along the said westerly property line of the 6.005 acre tract also being the said easterly property line of the 1.226 acre tract, North 04° 27' 04" East, 2.33 feet to the **True Point of Beginning**;

Containing 0.005 acres, more or less, subject to legal highways and other easements of record.

Basis of Bearing: The bearings herein were determined by GPS observation of Franklin County Geodetic Survey (FCGS) Monument Numbers 9918 and 2272 as shown on a Franklin County Engineer's Office Centerline Survey Plat (Drawing Number 0117-03). The bearings are based on the Ohio State Plane Coordinate System, South Zone, NAD 83 (2011 Adjustment) in which the bearing from FCGS 9918 to FCGS 2272 is North 04° 26' 51" East.

Basis of Stationing: The stationing referenced herein is from the plans known as "FRA-222-GENDER AT REFUGEE" on file with the Ohio Department of Transportation, District 6, and the City of Columbus, Ohio.

Prior Instrument References as of the date of this survey was prepared, Franklin County Recorder's, Instrument Number 200709280170419.

All Iron Pins Set are 3/4" dia. by 36" long with 3" Aluminum ID Cap stamped WILLIS S7996.
