Situated in the State of Ohio, County of Franklin, City of Columbus, and being located in Section 1, Township 11 North, Range 21 West, Congress Lands, and being out of that 1.643 acre tract of land described in a deed to **Thorntons, Inc.**, of record in Instrument Number 200809090136930, of the Franklin County Deed Records, Auditor's Parcel number 530-287464 and more particularly described as follows:

Beginning at a 3/4"x 36" Iron Pin with a 3" aluminum cap in a standard ODOT monument box to be set in the pavement at the intersection of the centerline construction of Refugee Road, and centerline construction of Gender Road, being STA 112+30.93 Refugee Road and equaling STA 216+59.94 Gender Road, as shown on the Centerline Plat of FRA-222 (Gender Road) and recorded in Plat Book 117, Page 72, of the Plat Records of Franklin County;

Thence along the said centerline construction of Refugee Road, South 77° 34' 14" East, 100.89 feet to a point being at centerline construction STA 113+31.82;

Thence leaving said centerline construction of Refugee Road, North 12° 25' 46" East, 46.03 feet, to a point being on the existing north right of way line of Refugee Road as conveyed to the City of Columbus, of record in Official Record Volume 10744, Page I15, of the Franklin County Deed Records, also being the existing east L/A right of way line of Gender Road as conveyed to the City of Columbus, of record in Official Record Volume 10744, Page I15, of the Franklin County Deed Records, being at centerline construction STA 113+31.82, 46.03 feet LT;

Thence along the said existing east L/A right of way line of Gender Road as conveyed to the City of Columbus, of record in Official Record Volume 10744, Page I15, of the Franklin County Deed Records, North 40° 34' 50" West, 8.27 feet, to an Iron Pin Set being at centerline construction STA 113+25.22, 51.00 feet LT; said point being the **True Point of Beginning** for the parcel herein described;

Thence continuing along the said existing east L/A right of way line of Gender Road as conveyed to the City of Columbus, of record in Official Record Volume 10744, Page I15, of the Franklin County Deed Records, North 40° 34' 50" West, 10.43 feet, to a point at centerline construction STA 113+16.89, 57.28 feet LT;

Thence crossing through said grantor's 1.643 acre tract, North 29° 43' 44" West, 38.35 feet to a point being at centerline construction STA 217+36.58, 71.40 feet RT;

Thence continuing across the said 1.643 acre tract, North 04° 18' 05" East, 151.68 feet to a point being at centerline construction STA 218+88.26, 70.76 feet RT;

Thence across the said 1.643 acre tract, South 77° 34' 14" East, 219.50 feet to a point being on the easterly property line of said 1.643 acre tract also being a westerly property line of a 16.205 acre tract of land as conveyed to Stratford Lakes LLC, in Instrument Number 201107060083179 of the Franklin County Deed Records, being at centerline construction STA 115+43.76, 74.00 feet LT;

Thence along the said easterly property line of the 1.643 acre tract and being a portion of the said westerly property line of the 16.205 acre tract, and being a portion of the said existing north right of way line of Refugee Road as conveyed to the City of Columbus, of record in Official Record Volume 10744, Page I15, of the Franklin County Deed Records, also being a portion of the westerly right of way line of Refugee Road as dedicated to the City of Columbus, of record in Plat Book 72, Page 31, of the Franklin County Deed Records, South 04° 21' 18" West, 23.23 feet to an Iron Pin Set being at centerline construction STA 115+47.03, 51.00 feet LT;

Thence across the said 1.643 acre tract, North 77° 34' 14" West, 221.80 feet to the **True Point of Beginning**;

Containing 0.185 acres, more or less, subject to legal highways and other easements of record.

Basis of Bearing: The bearings herein were determined by GPS observation of Franklin County Geodetic Survey (FCGS) Monument Numbers 9918 and 2272 as shown on a Franklin County Engineer's Office Centerline Survey Plat (Drawing Number 0117-03). The bearings are based on the Ohio State Plane Coordinate System, South Zone, NAD 83 (2011 Adjustment) in which the bearing from FCGS 9918 to FCGS 2272 is North 04° 26' 51" East.

Basis of Stationing: The stationing referenced herein is from the plans known as "FRA-222-GENDER AT REFUGEE" on file with the Ohio Department of Transportation, District 6, and the City of Columbus, Ohio.

Prior Instrument References as of the date of this survey was prepared, Franklin County Recorder's, Instrument Number 200809090136930.

All Iron Pins Set are 3/4" dia. by 36" long with 3" Aluminum ID Cap stamped WILLIS S7996.
