[Surveyor's description of the premises follows]

Situated in the State of Ohio, County of Franklin, City of Columbus, and being located in Section 1, Township 11 North, Range 21 West, Congress Lands, and being out of that 1.777 acre tract of land described in a deed to **Stephen J. & Annette M. Kuss**, of record in Instrument Number 199611150229240, of the Franklin County Deed Records, Auditor's Parcel number 530-237171 and more particularly described as follows:

Beginning at a 3/4"x 36" Iron Pin with a 3" aluminum cap in a standard ODOT monument box to be set in the pavement at the intersection of the centerline construction of Refugee Road, and centerline construction of Gender Road, being STA 112+30.93 Refugee Road and equaling STA 216+59.94 Gender Road, as shown on the Centerline Plat of FRA-222 (Gender Road) and recorded in Plat Book 117, Page 72, of the Plat Records of Franklin County;

Thence along the said centerline construction of Refugee Road, South 77° 34' 14" East, 614.52 feet to a point of curve being at centerline construction STA 118+45.45;

Thence continuing along the said centerline construction of Refugee Road with a curve to the left with a radius of 1273.00 feet, length of 424.27 feet, delta of 19° 05' 44", chord length of 422.31 feet and bearing of South 87° 07' 06" East to a point on curve being at centerline construction STA 122+69.72;

Thence leaving said centerline construction of Refugee Road, North 06° 39' 58" West, 60.34 feet, to an Iron Pin Found on curve being on the existing north right of way line of Refugee Road as dedicated to the City of Columbus, of record in Plat Book 72, Page 31, of the Franklin County Deed Records, also being the westerly property line of said 1.777 acre tract also being an easterly property line of a 16.205 acre tract of land as conveyed to Stratford Lakes LLC, in Instrument Number 201107060083179 of the Franklin County Deed Records, being at centerline construction STA 122+69.72, 60.34 feet LT. said Iron Pin Found being the **True Point of Beginning** for the parcel herein described;

Thence along the said westerly property line of the 1.777 acre tract also being the said easterly property line of the 16.205 acre tract, North 06° 00' 10" West, 24.66 feet to a point being at centerline construction STA 122+70.03, 85.00 feet LT;

Thence crossing through said grantor's 1.777 acre tract, North 82° 45' 29" East, 23.31 feet to a point being at centerline construction STA 122+95.00, 85.00 feet LT;

Thence continuing across the said 1.777 acre tract, South 07° 48' 14" East, 24.98 feet to a point on curve being on the said existing north right of way line of Refugee Road as dedicated to the City of Columbus, of record in Plat Book 72, Page 31, of the Franklin County Deed Records, being at centerline construction STA 122+95.00, 60.02 feet LT;

Thence along the said existing north right of way line of Refugee Road as dedicated to the City of Columbus, of record in Plat Book 72, Page 31, of the Franklin County Deed Records, with a curve to the right with a radius of 1440.00 feet, length of 24.09 feet, delta of 00° 57' 30", chord length of 24.09 feet and bearing of South 83° 31' 05" West to the **True Point of Beginning**;

Containing 0.014 acres, more or less, subject to legal highways and other easements of record.

Basis of Bearing: The bearings herein were determined by GPS observation of Franklin County Geodetic Survey (FCGS) Monument Numbers 9918 and 2272 as shown on a Franklin County Engineer's Office Centerline Survey Plat (Drawing Number 0117-03). The bearings are based on the Ohio State Plane Coordinate System, South Zone, NAD 83 (2011 Adjustment) in which the bearing from FCGS 9918 to FCGS 2272 is North 04° 26' 51" East.

Basis of Stationing: The stationing referenced herein is from the plans known as "FRA-222-GENDER AT REFUGEE" on file with the Ohio Department of Transportation, District 6, and the City of Columbus, Ohio.

Prior Instrument References as of the date of this survey was prepared, Franklin County Recorder's, Instrument Number 199611150229240.

All Iron Pins Set are 3/4" dia. by 36" long with 3" Aluminum ID Cap stamped WILLIS S7996.
