Being a parcel of land lying on the right side of the centerline of right of way of Holt Road as shown on the centerline plat of FRA-Georgesville/Holt Improvements as recorded in Plat Book ______, Page _____ of the records of Franklin County and being further described as follows:

Commencing, for reference, at an iron pin (set) at the southwest corner of Lot 1 in the dedication of Holt Road, as shown on Georgesville Square Subdivision and Dedication of Holt Road, recorded in Plat Book 87, Page 11, said corner being 50.00 feet right of station 22+63.85; Thence, northwesterly, along the easterly existing right of way line of Holt Road, with an arc distance of 45.22 feet, along the arc of a curve deflecting to the left, having a central angle of 02 degrees 33 minutes 18 seconds, a radius of 1014.03 feet, and a chord that bears North 24 degrees 31 minutes 54 seconds West, a distance of 45.22 feet to an iron pin (set), 50.00 feet right of station 23+06.84; Thence, across the grantor's tract, with an arc distance of 24.70 feet, along the arc of a curve deflecting to the right, having a central angle of 29 degrees 47 minutes 50 seconds, a radius of 47.50 feet, and a chord that bears North 38 degrees 08 minutes 33 seconds East, a distance of 24.43 feet, to an iron pin (set), 72.00 feet right of station 23+16.83, said pin set also being the **Point of Beginning** of the parcel herein described;

Thence, across the grantor's tract, South 27 degrees 15 minutes 53 seconds East, a distance of 14.44 feet to a point 135.00 feet right of station 23+25.00;

Thence, across the grantor's tract, South 55 degrees 10 minutes 40 seconds West, a distance of 63.65 feet to the **Point of Beginning**, containing 0.026 acres, of which the present road occupies 0.000 acres, and is contained within Franklin County Auditor's Permanent Parcel No. 010-240798.
