Being a parcel of land lying on the left side of the centerline of right of way of Automall Drive as shown on the centerline plat of FRA-Georgesville/Holt Improvements as recorded in Plat Book ______, Page _____ of the records of Franklin County and being further described as follows:

Commencing, at a P.K. nail (found) at the intersection of the centerlines of Automall Drive and a service road lying north and parallel to Georgesville Road, as shown on the recorded plat of Dedication of Automall Drive and Easements, in Plat Book 67, Page 20, said corner being at station 50+84.99; Thence, across the westerly existing right of way of Automall Drive, South 75 degrees 25 minutes 52 seconds West, a distance of 40.00 feet to a point 40.00 feet left of station 50+84.96; Thence, North 14 degrees 31 minutes 14 seconds West, a distance of 13.01 feet to the intersection of the westerly existing right of way line of Automall Drive and the northerly existing right of way line of Georgesville Road, 40.00 feet left of station 50+97.97; Thence, North 14 degrees 31 minutes 14 seconds East, along the westerly existing right of way line of Automall Drive, a distance of 23.56 feet, to an iron pin (set), 40.00 feet left of station 51+21.53, said pin (set) also being the **Point of Beginning** of the parcel herein described;
