Sir,

The following investigation was conducted concerning the City of Columbus' 2021 annual objection to the renewal of liquor permit **0023900** issued to **Abdullah Mart Inc.**, which is doing business as **Save Way Mini Mart**, located at **2585 W. Broad Street, Columbus, Ohio 43204**. The record owner of said permit is **Adullah Qasim Ansar**.

After reviewing the State of Ohio, Franklin County, and City of Columbus records regarding the above liquor permit establishment, the following information has been compiled to support the objection to the renewal of the aforementioned permit issued by the State of Ohio.

The above listed liquor establishment has been issued **C1 and C2** permits by the Division of Liquor. This permit grants the permit holder the privilege to sell alcoholic beverages at the above listed address.

An inquiry of liquor violations revealed that the permit holder has received the following violations in **2021**:

IMPROPER CONDUCT (DRUG and DRUG PARAPHERNALIA POSSESSION BY THE PERMIT HOLDER)

A review of the Columbus Division of Police records revealed the Division of Police has created **(49) forty-nine** official police reports concerning incidents at the listed liquor establishment between **January 2020** and **November 2021**. 

In addition, the Columbus Division of Police have been dispatched to **2585 W. Broad Street, Columbus, Ohio 43204** on **(114) one-hundred fourteen** calls for service, **(42) forty-two** in 2020, and **(72) seventy-two** in 2021 at **Save Way Mini Mart**. These calls for service include responses to a stabbing, persons with a gun or knife, robberies, shots fired, fights, assaults, narcotics complaints, overdoses, intoxicated individuals needing assistance, disturbances (including disturbances with a high risk of violence and disturbances involving intoxicated individuals and open containers), arrest of persons with felony warrants, trespassing, domestic violence, a trash fire, property destruction, and motor vehicle theft.

The Columbus Division of Fire was also dispatched to the location **(21) twenty-one** times from October 2020 through October 2021, including for **(7) seven** overdoses.
