Sir,

The following investigation was conducted concerning the City of Columbus' 2021 annual objection to the renewal of liquor permit **2097745** issued to **Destination 2 Success LLC**, which is doing business as **Beverage Warehouse**, located at **847 E. 11<sup>th</sup> Avenue, Columbus, Ohio 43211**. The record owner of said permit is **Raghu R. Kondakrindhi**.

After reviewing the State of Ohio, Franklin County, and City of Columbus records regarding the above liquor permit establishment, the following information has been compiled to support the objection to the renewal of the aforementioned permit issued by the State of Ohio.

The above listed liquor establishment has been issued **C2, D1, and D8** permits by the Division of Liquor. This permit grants the permit holder the privilege to sell alcoholic beverages at the above listed address.

An inquiry of liquor violations revealed that the permit holder has received the following violations in **2021**:

A review of the Columbus Division of Police records revealed the Division of Police has created **(16) sixteen** official police reports concerning incidents at the listed liquor establishment between **January 2020** and **November 2021**. These reports referenced homicide, shots fired, weapons offenses, discharging firearms, recovered firearms, assaults, domestic violence, and liquor law offenses.



In addition, the Columbus Division of Police have been dispatched to **847 E. 11<sup>th</sup> Avenue, Columbus, Ohio 43211** on **(56) fifty-six** calls for service, **(34) thirty-four** in 2020, and **(22) twenty-two** in 2021 at **Beverage Warehouse**. These calls for service include responses to shots fired, robberies, fights, overdoses, narcotics complaints, intoxicated individuals needing assistance, disturbances (including disturbances with a high risk of violence and disturbances involving intoxicated individuals and open containers), indecent exposure, motor vehicle thefts, trespassing, O.V.I.'s, and domestic violence.

The Columbus Division of Fire was also dispatched to the location **(4) four** times from October 2020 through October 2021, including for **(3) three** overdoses.
