Sir,

The following investigation was conducted concerning the City of Columbus' 2021 annual objection to the renewal of liquor permit **41801750002** issued to **J MAC Investments LLC.**, which is doing business as **Moments Grill and Lounge** located at **2545 Petzinger Road, Columbus, Ohio 43209**. The recorded owner of said permit is **Tammy Scott**.

The City of Columbus also objected to the renewal of this permit in November 2020. The Ohio Department of Commerce Division of Liquor Control has not yet held a final hearing on that objection.

After reviewing the State of Ohio, Franklin County, and City of Columbus records regarding the above liquor permit establishment, the following information has been compiled to support the objection to the renewal of the aforementioned permit issued by the State of Ohio.

The above listed liquor establishment has been issued **D5 and D6** permits by the Division of Liquor. This permit grants the permit holder the privilege to sell alcoholic beverages at the above listed address.

A review of the Columbus Division of Police records revealed the Division of Police has created **(47) forty-seven** official police reports concerning incidents at the listed liquor establishment between **January 2020** and **November 2021**. These reports referenced shootings, stabbings, felony assaults, weapons offenses, recovered firearms, discharging firearms, menacing, sexual assaults, domestic violence, thefts from motor vehicles, and assaults, including:



These calls for service include responses to shootings, shots fired, stabbing, persons with guns, fights and disturbances, assaults, intoxicated individuals needing assistance, domestic disputes, motor vehicle thefts, property destruction, O.V.I.'s, loud noise, and arrest of persons with outstanding warrants.
