### **Background:**

Recreation and Parks entered into contract with URS Corporation in 2009 for engineering services for the Goodale Street Bike Improvements. The final plans will require additional plan sheets, right-of-way survey, and specifications for the project to be done in May 2013. The additional services will be used for additional plan sheets to construct a section of trail along 582 Goodale Street, to provide an additional right-of-way survey, and to perform additional final plan specifications.

WHEREAS, it is necessary to modify Contract EL007114000000 with the URS Corporation for additional enginneering services related to the Goodale Street Bike Improvements Project; and

WHEREAS, funds are being moved to alternate projects within Fund 702 to establish correct funding locations for this project and to make corrections to the Capital Improvement Budget; and

**WHEREAS**, the 2012 Capital Improvement Budget will be amended to reflect the fund transfers from projects within Fund 702 for the Goodale Street Bike Improvements Camp Chase Trail Project modification; and

WHEREAS, an emergency exists in the usual daily operation of the Recreation and Parks Department in that it is immediately necessary to modify said contract with the URS Corporation for additional engineering services related to the Goodale Bike Street Improvements Project so that engineering work can be completed in sixty (60) days maintaining construction schedule for this project thereby preserving the public health, peace, property, safety, and welfare; NOW, THEREFORE

**SECTION 1**. That the City Auditor is hereby authorized to transfer \$27,249.00 within the voted Recreation and Parks Bond Fund 702 for the projects listed below:

**SECTION 5**. That the City Auditor is hereby authorized to transfer the unencumbered balance in a project account to the unallocated balance account within the same fund upon receipt of certification by the Director of the Department administering said project that the project has been completed and the monies are no longer required for said project; except that no transfer shall be so made from a project account funded by monies from more than one source.

**SECTION 6**. That the City Auditor is authorized to make any accounting changes to revise the funding source for all contracts or contract modifications associated with this legislation.

**SECTION 7**. That for the reasons stated in the preamble hereto, which is hereby made a part hereof, this ordinance is hereby declared to be an emergency measure and shall take effect and be in force from and after its passage and approval by the Mayor, or 10 days after passage if the Mayor neither approves nor vetoes the same.
