BACKGROUND: This legislation authorizes the Director of Public Utilities to amend the water service and sewer service agreements with the City of Whitehall, Ohio. The City of Columbus and the City of Whitehall entered into a sewer service contract on August 10th, 1981 in accordance with Ordinance Number 1878-81, entered into an amended agreement on September 1, 1987 in accordance with Ordinance Number 922-87, and entered into an amended agreement on January 23rd, 2013 in accordance with Ordinance 2766-2012. The current sewer service agreement remains in full force and effect until midnight on January 23, 2053. The City of Columbus and the City of Whitehall entered into a water service agreement on October 24, 1994 in accordance with Ordinance Number 2223-94 and entered into an amended agreement on March 4th, 2013 in accordance with Ordinance 2766-2012. The current water service agreement remains in full force and effect until midnight on March 4th, 2038.

The water and sewer service area boundaries are being updated to reflect corporate boundaries of Whitehall, including the addition of some parcels not currently covered under the existing agreements. All other existing covenants, provisions, terms and conditions thereof shall be binding, and the only purpose of this modification is to modify the service area boundaries.

To authorize the Director of Public Utilities to amend the current water service and sewer service agreements with the City of Whitehall to modify the service area boundaries.

WHEREAS, the City of Columbus and the City of Whitehall entered into a sewer service agreement on August 10th, 1982, pursuant to Ordinance 1878-81, and

WHEREAS, the City of Columbus and the City of Whitehall entered into a modification to the original sewer service agreement on September 1st, 1987 pursuant to Ordinance 922-87, and

WHEREAS, the City of Columbus and the City of Whitehall entered into a modification to the original sewer service agreement on January 23rd, 2013 pursuant to Ordinance 2766-2012, and

WHEREAS, the City of Columbus and the City of Whitehall entered into a water service agreement on October 24th, 1994, pursuant to Ordinance 2223-94, and

WHEREAS, the City of Columbus and the City of Whitehall entered into a modification to the original water service agreement on March 4th, 2013 pursuant to Ordinance 2766-2012, and

WHEREAS, the water and sewer service boundaries for the City of Whitehall have been updated to reflect corporate boundaries of Whitehall, including the addition of some parcels not currently covered under existing agreements, and

WHEREAS, all other existing covenants, provisions, terms and conditions thereof shall be binding, and the only purpose of this modification is to modify the water and sewer service area boundaries, and

WHEREAS, it has become necessary in the usual daily operation of the Division of Water and Division of Sewerage and Drainage, Department of Public Utilities, to authorize the Director of Public Utilities to amend the current water service agreement and sewer service agreement with the City of Whitehall, for the preservation of the public health, peace, property and safety; now, therefore

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBUS:

SECTION 1. That the Director of Public Utilities is authorized to amend the current water service and sewer service agreements with the City of Whitehall to modify the service area boundaries. All other existing covenants, provisions, terms and conditions thereof shall be binding, and the only purpose of this modification is to modify the service area boundaries.

SECTION 2. That this Ordinance shall take effect and be in force from and after the earliest period allowed by law.
