SITUATED IN THE STATE OF OHIO, COUNTY OF FRANKLIN, CITY OF COLUMBUS, AND IN QUARTER TOWNSHIP 3, TOWNSHIP 1, RANGE 16, UNITED STATES' MILITARY LANDS BEING A SUBDIVISION OF 7.624 ACRES AND BEING PART OF 77.083 ACRES TRACT OF LAND AS DESCRIBED BY DEEDS OF RECORD IN INSTRUMENT NUMBER 202305250051100, TO TRIDENT BROAD DEVELOPMENT, LLC. ALL REFERENCES ARE TO RECORDS OF THE RECORDER'S OFFICE, FRANKLIN COUNTY, OHIO.

THE UNDERSIGNED, TRIDENT BROAD DEVELOPMENT, LLC, OWNER OF THE LANDS PLATTED HEREIN, DULY AUTHORIZED IN THE PREMISES, DOES HEREBY CERTIFY THAT THIS PLAT CORRECTLY REPRESENTS ITS "DEDICATION PLAT OF WESTBOURNE AVENUE EXTENSION AND EASEMENTS", BEING A SUBDIVISION OF 7.624 ACRES AND DOES HEREBY ACCEPT THIS PLAT OF SAME AND DEDICATES TO PUBLIC USE, AS SUCH, ALL OR PARTS OF TAYLOR STATION ROAD, WESTBOURNE AVENUE, CORRINA DRIVE AND EASEMENTS SHOWN HEREON AND HERE TO FORE DEDICATED.

EASEMENTS ARE HEREBY RESERVED IN AND DEDICATED OVER AND UNDER AREAS DESIGNATED ON THIS PLAT AS "DRAINAGE EASEMENTS" FOR THE CONSTRUCTION, OPERATION AND MAINTENANCE OF STORM SEWER AND ASSOCIATED APPURTENANCES BENEATH THE SURFACE OF THE GROUND AND, WHERE NECESSARY, FOR THE CONSTRUCTION, OPERATION AND MAINTENANCE OF SERVICE CONNECTIONS TO ALL ADJACENT LOTS AND LANDS AND FOR STORM WATER DRAINAGE. WITHIN THOSE AREAS DESIGNATED "DRAINAGE EASEMENT" ON THIS PLAT, AN ADDITIONAL EASEMENT IS HEREBY RESERVED FOR THE PURPOSE OF CONSTRUCTING, OPERATING AND MAINTAINING MAJOR STORM WATER DRAINAGE SWALES AND OR OTHER STORM WATER DRAINAGE FACILITIES. NO ABOVE GRADE STRUCTURES, DAMS OR OTHER OBSTRUCTIONS TO THE FLOW OF STORM WATER RUNOFF ARE PERMITTED WITHIN DRAINAGE EASEMENT AREAS AS DELINEATED ON THIS PLAT UNLESS APPROVED BY THE CITY OF COLUMBUS, DIVISION OF SEWERAGE AND DRAINAGE. FURTHERMORE, IN ACCORDANCE WITH THE TERMS AND REGULATIONS OF SECTION 3123.08(c)(8) OF THE COLUMBUS CITY CODES.

WITHIN THOSE AREAS DESIGNATED "ACCESS EASEMENT" ON THIS PLAT, A PERPETUAL HIGHWAY EASEMENT IS GRANTED TO THE CITY OF COLUMBUS IN, OVER, UNDER, ACROSS, AND THROUGH THE SUBJECT PROPERTY, FOR THE PURPOSE OF ACCESSING, EXCAVATING, CONSTRUCTING, INSTALLING, RECONSTRUCTING, REPLACING, REMOVING, CONTROLLING AND OPERATING THE ROADWAY. THE PURPOSE IS TO PROVIDE A PUBLIC USE TURNAROUND THAT SHALL BE MAINTAINED OPEN AT ALL TIMES, UNLESS PRIOR APPROVAL IS GIVEN BY THE CITY.

WITHIN THOSE AREAS DESIGNATED "PERMANENT EASEMENT" ON THIS PLAT, AN ADDITIONAL EASEMENT IS HEREBY GRANTED TO THE CITY OF COLUMBUS FOR A SHARED-USE PATH FOR USE BY THE PUBLIC.
