Situated in the State of Ohio, County of Franklin, City of Columbus, located in Farm Lot 14 of Flavel Tuller's Survey of Section 1, Township 2 North, Range 19 West, United States Military Lands, as recorded in Plat Book 3, Page 60, and being a part of Lot 3 of the Summerwood Section No. 1 Subdivision as recorded in Plat Book 51, Page 33, as conveyed to Matthew R. Mershimer and Amanda M. Mershimer by deed of record in Instrument Number 200709110160746 and Instrument Number 201008050100036, all records of the Recorder's Office, Franklin County, Ohio, and being more particularly described as follows:

Being a parcel of land located on the right side of the Plat of the Centerline of Right-of-Way of FRA-C.R. 61-1.10, as recorded in Plat Book\_\_\_\_, Page\_\_\_\_;

**Beginning** at the northeast corner of said Lot 3, being 40.00 feet right of Hard Road centerline station 149+82.48;

Thence South 02 degrees 21 minutes 18 seconds West, a distance of 10.00 feet along the easterly line of said Lot 3 to a point being 50.00 feet right of Hard Road centerline station 149+82.48;

Thence North 87 degrees 38 minutes 42 seconds West, a distance of 104.44 feet across said Lot 3 to a point in the westerly line of said Lot 3, being 50.00 right of Hard Road centerline station 148+78.04;

Thence North 12 degrees 56 minutes 16 seconds West, a distance of 5.18 feet along the westerly line of said Lot 3, to an iron pin set at the intersection with the proposed southerly Right-of-Way line of Hard Road, being 45.00 right of Hard Road centerline station 148+76.67;

Thence South 87 degrees 38 minutes 42 seconds East, a distance of 43.33 feet across said Lot 3, and along the proposed southerly Right-of-Way line of Hard Road, to an iron pin set being 45.00 right of Hard Road centerline station 149+20.00;

Thence North 02 degrees 21 minutes 18 seconds East, a distance of 5.00 feet across said Lot 3, and along the proposed southerly Right-of-Way line of Hard Road, to an iron pin set at the intersection with the existing southerly Right-of-Way line of Hard Road, being 40.00 right of Hard Road centerline station 149+20.00;

Thence South 87 degrees 38 minutes 42 seconds East, a distance of 62.48 feet along the northerly line of said Lot 3 to the **Point of Beginning**, containing 0.019 acres, more or less;

Of the above described area, 0.019 acres is contained within the Franklin County Auditor's Parcel 610-171807.

The bearing datum of the afore-described parcel is based upon the Ohio State Plane Coordinate System, South Zone, NAD 1983 (1986 Adjustment), as measured using G.P.S. methods through the Franklin County Engineer's stations FRANK 74, FRANK 174, FCGS 7772, FCGS 6651, FCGS 2232, and FRANK 2218 RESET.

This description was based upon an actual field survey of Hard Road by Stantec Consulting Services, Inc., in October and November of 2010, under the direction of Tim A. Baker, Registered Surveyor Number 7818.

Iron Pins Set are 3/4 inches in diameter by 30 inches long with a 2 inch aluminum cap placed on top bearing the name "ODOT R/W" and "STANTEC".
