3. A full description of all work to be performed including a full description of work to be performed during any known phasing of the contract.

This is a contract for one of the key, time-critical wastewater plants construction projects in the City's Wet Weather Management Plan (WWMP) program, for the period through 2010. The work in that program is a very substantial group of sewer capital improvement projects (CIPs), both collections systems and treatment works improvements, which have been agreed to by the City and Ohio EPA in order to conform to the requirements of the City's consent orders

The proposed contract with C. J. Mahan Construction Company, LLC is for Contract S71 – New Effluent Pump Station and Effluent Conduit. This contract Work consists of the construction of an Effluent Pump Station, an Effluent Control Building, an Effluent Metering Chamber, an Effluent Metering Building, Effluent Transition Chamber, an Effluent Sampling Building, an Effluent Electrical Building, a Disinfection Effluent Conduit, an Effluent Conduit, and an Effluent Conduit Structure, excavation, backfilling, new roadways and pavement, underground utilities installation, installation of mechanical and electrical equipment, and other work as shown and described in the Bidding Documents.

4. A narrative timeline for the contract including a beginning date, beginning and ending dates for known phases of the contract and a projected ending date.

Contract work is required to be substantially completed within 620 days from the date that a Notice To Proceed (NTP) is given by the City and final completion within 680 days from the date that a Notice To Proceed (NTP) is given by the City.

5. An estimate of the full cost of the Contract including a separate estimate of any and all phases or proposed future contract modifications.

The bid amount and proposed award amount is \$48,849,350.00 including a 10% construction contingency amount that will be utilized to fund needed and approved changes in the work. No contract modifications are anticipated at this time; however, construction exigency might later compel modification of this contract, if unforeseen difficulties are encountered.
