With this funding, a total of \$3.5M will have been appropriated for Project Dry Basement. This represents a completion of the three year, \$3M commitment that the Mayor and Council made in July, 2004. As has been the case in the past two years, funds will continue to be used to have plumbing contractors install backwater valves in single family and duplex properties in Columbus that have had a documented sanitary sewer backup caused by a problem in the city's mainline sewer.

Heavy rains in June have resulted in over 125 water-in-basement claims being filed with the Division of Sewerage and Drainage. If all these claims were approved, installation of backwater prevention devices would exhaust all funds remaining on plumbing contracts in place. The

department requests authority to increase contracts with The Waterworks, Holdridge Mechanical, and Fox Mechanical, so as to provide sufficient funding to address the current claims and provide some contingency funding for possible future claims. The department was anticipating rebidding these services early in 2009 and will still do that. Funding requested through this ordinance will allow the continuation of the program until new contracts are in place in 2009.

An explanation of why the work to be performed as part of the contract modification cannot be bid out. (Indicating the work to be a logical extension of the contract is not sufficient explanation This third, second, and first modification, was originally anticipated as part of the Project Dry Basement program.

The original appropriation was for \$1M. This was followed by another \$1M appropriation, a \$200K appropriation, and then \$800K. Including the current modification of \$500k the total adds up to the \$3.5M.
