Situated in the State of Ohio, City of Columbus, Franklin County, Half Section 8, Section 7, Township 12 N, Range 21 W, Refugee Lands and being part of Lot 13 of Mayfair as recorded in Plat Book 19, Page 40 and conveyed to Antwan S. Williams in Instrument 201205010060260 in the Franklin County Recorder's Office. The below described parcel laying on the right side of the centerline of existing right of way for James Road in project James Road at East Broad Street as platted by 2LMN, Inc. as recorded in Instrument 202108240151066, and being more particularly described as follows:

COMMENCING at a point at the grantor's southwest corner being on the easterly existing right of way for James Road, said point being 40.00 feet right of centerline of existing right of way for James Road at station 55+65.10 and being the **TRUE POINT OF BEGINNING** for the parcel herein described:

- 1) **Thence**, along the grantor's west line and the easterly existing right of way for James Road, **North 04 degrees 04 minutes 04 seconds East, 52.08** feet to a point at the grantor's northwest corner, said point being 40.00 feet right of the centerline of existing right of way for James Road at station 56+17.18;
- 2) **Thence**, along the grantor's north line, **South 85 degrees 55 minutes 39 seconds East, 5.00** feet to a point, said point being 45.00 feet right of the centerline of existing right of way for James Road at station 56+17.18;
- 3) **Thence**, across the grantor's tract, **South 04 degrees 04 minutes 04 seconds West, 52.08** feet to a point, said point being 45.00 feet right of the centerline of existing right of way for James Road at station 55+65.10;
- 4) **Thence**, across the grantor's tract, **North 85 degrees 56 minutes 23 seconds West, 5.00 feet** to the **TRUE POINT OF BEGINNING**, containing 0.006 acres.
