Note all firms had MBE/FBE participation proposed for their project teams. Selected consultant has three MBE and one FBE on project team. Note one MBE firm will not be utilized in this phase of the work. MBE/FBE firms will participate at 9.3% of this phase of the work.

2. <u>A full description of all work to be performed including a full description of work to be performed during any known phasing of the contract.</u>

This project entails professional consulting/engineering services to provide full-service assistance to the City to evaluate options and design an upgrade to Parsons Avenue Water Plant (PAWP) to reliably treat a 50 MGD combination of ground water, ground water under the direct influence of surface water (GWUDI) and surface water. The selected professional service firm will prepare technical reports of evaluation findings and make recommendations for improvements and/or alterations to the physical facilities and treatment processes, prepare construction documents for the selected design, and perform contract administration services. In addition, the project shall evaluate and design an upgrade to replace existing plant electrical service, including the electrical switch gear for the plant upgrade. This shall also include electrical monitoring and or conditioning of incoming power to the PAWP. Also, the consultant shall make recommendations on whether to bid the electrical upgrades as a separate contract or as a combined project with the GWUDI plant upgrades. In addition, the Consultant shall perform Construction Administration / Construction Inspection services for the plant upgrade and electrical improvements construction.

3. A <u>narrative timeline for the contract including a beginning date, beginning and ending dates for known phases of the contract and a projected ending date.</u>

See attached project schedule (Revised PAWP Project Schedule.pdf). The current contract entails tasks identified as Preliminary Engineering, including Bench-Scale, Demonstration and Microbial Studies which will be compiled in a Preliminary Engineering Report. These tasks are anticipated to be completed within 16 months of the Notice to Proceed. The Final Design phase will be completed after legislation approval to modify the current contract. At this time it is anticipated the Final Design phase will be completed within 32 months of the Notice to Proceed. The Construction Administration/ Construction Inspection phase will be completed after legislative approval to modify the current contract (second anticipated modification). Construction completion is anticipated by 2012.

4. An estimate of the full estimated cost of the Contract including a separate estimate of any and all phases or proposed future contract modifications.

Detailed costs for additional phases of the work have not been determined at this time. For budgetary purposes \$5,000,000 have been included in the proposed 2008 CIP for detailed

engineering services and \$1,500,000 have been included in the 2010 CIP for engineering construction services.
