The purpose of this project is to construct necessary improvements to the water distribution system in the Union Avenue Area. The improvements identified in the scope of work will replace or rehabilitate water lines that have high break histories and require frequent maintenance. This project includes replacing or rehabilitating approximately 11,920 linear feet of 6-inch and 8-inch and water lines within the project area.

This project is located within the "Hilltop" and "Franklinton" community planning areas, with the majority of the project in the Hilltop planning area. The streets include Union Ave., Brehl Ave., Dana Ave., Princeton Ave., Sullivant Ave., West Park Ave., Porter St., Wrexham Ave., Mound St., Whitehead Rd., Clarendon Ave., Vauxhall Pl., Greenville Rd., Western Hill Ct., Robin Hill Ct.
