

**Ordinance Number 0115-2014**

**American Municipal Power, Inc (AMP, Inc.) contract modification for purchased power.**

**Information to be included in all Legislation Modifying Contracts:**

The names of all companies bidding or submitting an RFP or RFSQ for the original contract.

Bids were not taken for the original contracts. AMP, Inc. is a non-profit organization for state municipalities and, acting as a broker, has contracted on the City's behalf competitive prices through a bidding process.

Supply wholesale electric power to the Division of Power and provide necessary services associated with the delivery of said energy. The level of funding in this Ordinance reflects that AMP, Inc. will become the Division's primary supplier of wholesale electric power beginning June 1, 2014.

Contracts will remain open unless terminated in accordance with the terms of the Master Services Agreement, Section 2.1.

A description of any and all modifications to date including the amounts of each modification and the Contract Number associated with any modification to date. (List each modification separately)

This modification is solely for the purpose of increasing the funding for the purchase of wholesale electric power and associated services. There is no modification to the terms or scope of the contract.
