BEGINNING at the northeast corner of said 0.115 acre tract, said point being the intersection of south right of way line of the first alley (15' public right of way) north of Gates Street (50' public right of way) with the west right of way line of Ann Street (40' public right of way), 20.00 feet left of centerline Station 207+43.43;
