The purpose of this project is to design street lighting for the Valleyview area of Columbus. There is currently no street lighting along Valleyview Drive between Hague Avenue and Wilson Road. There is also no street lighting in the residential areas both north and south of Valleyview between the same borders. This project will prepare the complete design of the required street lighting for this area.
