The Department of Public Service solicited Requests for Proposals for Roadway Improvements - 2010-2012 General Engineering Contracts. Three contracts will be awarded - \$200,000 - and will be funded from cash.

The intent of this project is to provide the City of Columbus, Department of Public Service, additional resources to perform various engineering and surveying tasks for all divisions in the department: Mobility Options, Planning and Operation, and Design and Construction. The projects developed under this program are typically small to moderate size improvements, and frequently include a significant emphasis on pavement rehabilitation, curb replacement, sidewalks, curb ramps, drainage, minor intersection improvements, bridge repair/rehabilitation, and other minor rehabilitations and aesthetic improvements as requested.

The project was advertised on the Vendor Services web site from June 10, 2010, to July 6, 2010. The City received twelve (12) responses. All were fully evaluated when the Evaluation Committee met on August 3, 2010.

This RFP Evaluation Committee included three (3) voting members from the Department of Public Service – Megan Blackford, Patti Austin, and Hassan Zahran – representatives from EBOCO were invited to attend, but declined, and myself.

Three contracts shall be awarded from this single procurement effort. The Committee recommends Columbus Engineering Consultants, Crawford Murphy and Tilling, and W.E. Stillson for the following reasons:

Columbus Engineering Consultants:

- 1. This firm has a solid history of producing a quality product in past GE contracts. They have 7 past GE contracts with the City of Columbus.
- 2. The PM assigned to this project would be the same PM who successfully administered the past projects.
- 3. Their scope shows they understand what needs to go into a project that would be awarded through the GE process.

Crawford Murphy and Tiling:

- 1. Very complete scope encompassing all of the elements needed for a GE contract. They also showed impressive cost containment numbers and that they saved the Indiana DOT \$ 168 million on its Top Project due to value engineering.
- 2. Very complete statement as to green and sustainable treatments that could be used in the GE projects.

WE Stilson:

- 1. Their PM has managed the GE contract for the City of Hilliard and many small, urban projects similar to the type that would be awarded in this GE contract.
- 2. Past experience were projects very similar to the type we may award in a GE contract, this shows they have experience in these types of projects.
