Caudy, in instrument 200912170182346 and 200009290198501 in the Franklin County Recorder's Office. The below described parcel laying on the left side of the Big Walnut Trail Central Section, and being more particularly described as follows:

COMMENCING at an iron pin set at the southeast corner of Lot 1 of the Strawberry Patch in Plat Book 57 Page 25 conveyed to Louis F. Speert in Instrument 200605120091836 and being on the westerly existing right of way of relocated Watt Road as acquired by the State of Ohio in Deed Book 2919, Page 89, said pin being 75.74 feet right of the centerline of Watt Road at station 22+44.01; Thence, on a line of South 59 degrees 54 minutes 15 seconds East 843.25 feet to an iron pin set, said pin being 18.25 feet left of the centerline of Big Walnut Trail Central Section at station 200+90.02; Thence, along the east line of Hildebrand Road, South 12 degrees 44 minutes 38 seconds West 31.53 feet to a point, said point being 11.49 feet right of the centerline of Big Walnut Trail Central Section at station 201+00.49 and being the **TRUE POINT OF BEGINNING** for the parcel herein described:

- 13) **Thence**, across said 5.609 acre tract, with a curve to the right having a radius 87.00 feet, a central angle of 30 degrees 23 minutes 07 seconds, an arc length of 46.14 feet, and a chord that bears **South 62 degrees 23 minutes 46 seconds West, 45.60 feet**, said point being 12.00 feet right of the centerline of Big Walnut Trail Central Section at station 201+47.19;
