The following investigation was conducted concerning the City of Columbus' 2016 – 2017 annual objection to the renewal of liquor permit held by Two Shots, Inc. located at 1571-1573 Lockbourne Rd., Columbus, Ohio. After reviewing the State of Ohio, Franklin County, and City of Columbus records regarding the above liquor permit establishment, the following information has been compiled with regard to the objection to the renewal of the permit issued to Two Shots, Inc. by the State of Ohio.

The above listed liquor establishment has been issued a liquor permit from the Division of Liquor Control # 9115530. The permit holder received a D – 2 permit, D – 2 – X permit, a D – 3 permit, and a D-3-A permit. These permits grant the permit holder the privilege to sell alcoholic beverages in the State of Ohio for on premise consumption as described by law.

The City of Columbus objected to the renewal of this establishment's liquor permits at the end of 2015; however a ruling has not yet been received from the State of Ohio. The establishment has been closed since January, 2016. The attached letter details the justification for the original objection to the renewal of this establishment's liquor permits.
