Thence South 86°42'33" East, through said 32.192 acre tract, for a distance of 1036.77 feet to a point on the easterly line of said 32.192 acre tract, being common to the easterly line of said Rickenbacker Intermodal Campus South – Logistics Court & Lot 1 Plat;

Thence South 02°32'01" West, continuing with said common line, for a distance of 60.01 feet to a point on said common line;

Thence North 86°42'33" West, through said 32.192 acre tract, for a distance of 1036.91 feet to a point on the westerly line of said 32.192 acre tract, being common to the westerly line of said Rickenbacker Intermodal Campus South – Logistics Court & Lot 1 Plat;

Thence North 03°43'40" East, continuing with said common line, for a distance of 60.00 feet to the **TRUE POINT OF BEGINNING**, and containing within said bounds 1.430 acres of land, more or less.
