Subject: Pedestrian Safety Improvements – COTA Sidewalks Phase 2

The Department of Public Service solicited Requests for Proposals for the Pedestrian Safety Improvements – COTA Sidewalks Phase 2 contract. The contract shall be funded from DPS' 2013 CIB.

This project includes preliminary and final engineering for improvements to install sidewalk curb ramps at three locations: Kenny Road from Upper Arlington corporation line to Francisco Road, Dierker Road from Henderson Road to Bethel Road, and Campus View Boulevard between High Street and Huntington Park Drive and Huntington Park Drive between Campus View Boulevard and the COTA Park and Ride. The project will include ROW acquisition and improvements necessary to accommodate drainage, if needed. The selected consultant will prepare final construction drawings for the improvements.

The project was formally advertised on the Vendor Services web site from April 26, 2013, to May 16, 2013. The city received five (5) responses. All proposals were deemed responsive and were fully evaluated when the Evaluation Committee met on May 22, 2013. The responding firms were:
