The City of Columbus Department of Technology (DoT) is pursuing a bid and contract to renew OnBase licensing and obtain professional services for a post upgrade enhancement project.

Pursuant to CCO 329.28, through utilization of requests for proposals, DoT received three (3) responses to RFQ026756 for OnBase Licensing and Professional Services. These responses were from 3SG Plus, eDocs Technologies, and DataBank IMX.

Over the course of one week and five touch base meetings, a three (3) member evaluation committee evaluated and scored these responses. Upon crafting their recommendation, the committee reached out to their recommended vendor references and met with one. As a result, after a follow-up committee meeting, two committee members adjusted their scores.

The committee ranked all proposals based on the following weighted criteria as a total average score:
