4. <u>A full description of all work to be performed including a full description of work to be performed during any known phasing of the contract</u>

This project is located in Clintonville and has been proposed for rehabilitation as recommended in the overall Clintonville Inflow and Infiltration study conducted under CIP 650405.2. This project will rehabilitate approximately 26,315 lineal feet of 8-inch through 15-inch clay sewers. Manholes will also be rehabilitated to help reduce inflow and infiltration entering the sanitary sewers. One sewer system overflow (SS0) is located within the project boundary (288). This project is included in the SSO Consent Decree.

5. <u>A narrative timeline for the contract including a beginning date, beginning and ending dates for known phases of the contract, and a projected ending date</u>

The contract will be initiated in September of 2006 and will continue until the work is completed. The contractor will have 360 days to complete the contract without financial penalties.

6. <u>An estimate of the full estimated cost of the contract including a separate estimate of any and all phases or proposed future contract modifications</u>

The bid amount and proposed award amount is \$1,682,067.60, which includes a 10% construction contingency amount that will be utilized to fund any needed and approved changes in the work. No contract modifications are anticipated at this time; however, construction exigency might later compel modification of this contract, if unforeseen difficulties are encountered.
