[Surveyor's description of the premises follows]

Situated in Half of Section 49, Township 12, Range 21 of the Refugee Lands within the City of Columbus, County of Franklin, and the State of Ohio and being part of a 0.738 acre tract and a 0.096 acre tract described in a deed to REALTY INCOME CORPORATION, a Maryland corporation in Instrument Number 200409170217948 (all records are on file at the Recorder's Office, Franklin County, Ohio), said parcel being more fully described as follows:

Commencing at a standard highway monument set at the intersection of the centerline of survey of Hamilton Road (S.R. 317) and centerline of survey of Groves Road (C. R. 212), said monument being the northeasterly corner of Half Section 50, the northwesterly corner of Half Section 49, the southeasterly corner of Half Section 35, the southwesterly corner of Half Section 36, Township 12, Range 21 of the Refugee Lands, said monument having a station of 63+52.59 Hamilton Road and 107+00.00 Groves Road as shown in FRA-SR317-10.63 Right of way plans prepared by ms consultants, inc. for the City of Columbus, Franklin County, Ohio;

Thence South 04° 22' 11" West, following the centerline of survey of Hamilton Rd., for a distance of 754.97 feet to station 55+97.62;

Thence South 85° 37' 49" East, leaving said centerline, for a distance of 75.00 feet to a point on the easterly right of way of Hamilton Road, said point being the northwesterly corner of said 0.738 acre tract, the southeasterly corner of a 1.261 acre tract a described to KIM K.ROOT AND JANE E. ROOT, MARK K. KENNEDY AND JULIE A. KENNEDY in Instrument Number 200501040002794 and being the **True Place of Beginning** of the parcel here in described;

Thence South 85° 29' 02" East, along the northerly line of said 0.738 acre tract, and the southerly line of said 1.261 acre tract, for a distance of 7.15 feet to a point;

Thence passing through said 0.738 acre tract, for the following four (4) courses and distances;

1. South 01° 34' 03" East, for a distance of 23.37 feet to a point;

2. South 04° 22' 11" West, for a distance of 30.00 feet to a point;
3. South 51° 11' 8" West, for a distance of 6.27 feet to a point;
4. South 4° 22' 11" West, for a distance of 102.56 feet to a point on the Southerly line of said 0.738 acre tract, and the northerly line of a 10.078 acre tract described in a deed to IMPALA CAPITAL, LLC in Instrument number 201309170158013;

Thence North 85° 08' 34" West, along the Southerly line of said 0.738 acre tract and the northerly line of said 10.078 acre tract, for a distance 5.00 feet to a point in the easterly right of way of Hamilton Road, said point being the southwesterly corner of the said 0.096 acre tract and the northwesterly corner of the said 10.078 acre tract;

Thence North 04° 22' 11" East, along the easterly right of way of Hamilton Road and the westerly line of said 0.096 acre and said 0.738 acre tracts, for a distance of 160.06 feet to the **True Point of Beginning**, and containing within said bounds 1026 square feet or 0.0235 acres of land, more or less.

The bearings for this description are based on the Ohio State Plane Coordinate System, South Zone, North American Datum 1983 (2011). With an established bearing of N 4° 22' 11" E between a monument set at the intersection of Refugee Rd. (C.R. 14) and Hamilton Rd. (S.R. 317) at Sta. 10+00.00 as shown in FRA-SR317-10.63 right of way plans prepared by ms consultants, inc. for the City of Columbus, Franklin County, Ohio and a monument set at the intersection of Groves Rd. and Hamilton Rd. (S.R. 317) Sta. 63+52.59 as shown in said right of way plans with a distance of 5352.59' between them. The above description was prepared by ms consultants, inc. from an actual field survey (2014-2017) and existing records.
