Sir,

The following investigation was conducted concerning the City of Columbus' 2025 annual objection to the renewal of liquor permit 08418994-88 issued to Speedway LLC, which is doing business as **Speedway**, located at **2875 Stelzer Rd, Columbus, OH 43219**.

After reviewing the State of Ohio, Franklin County, and City of Columbus records regarding the above liquor permit establishment, the following information has been compiled to support the objection to the renewal of the aforementioned permit issued by the State of Ohio.

The above listed liquor establishment has been issued a C-1, C-2, and D-6 permit by the Division of Liquor. These permits grant the permit holder the privilege to sell alcoholic beverages at the above listed address.

A review of the Columbus Division of Police records revealed the Division of Police has nineteen (19) official police reports concerning incidents at the listed liquor establishment between **January 2024** and **November 2025**. These reports referenced assault, public intoxication, fights, armed robbery, and people with guns, including:

**January 10, 2024 – Menacing**  
**August 11, 2024 – Robbery**  
**December 30, 2024 – Robbery**  
**February 23, 2025 – Assault**  
**July 24, 2025 – Robbery**

**July 27, 2025 – Assault**  
**August 2, 2025 – Assault**  
**September 24, 2025 – Assault**  
**October 1, 2025 – Assault**  
**October 25, 2025 – Robbery**

In addition, the Columbus Division of Police and Division of Fire have been dispatched to **2875 Stelzer Rd, Columbus, OH 43219, Franklin County** on 195 calls for service, eighty-nine (89) in 2024, and 113 in 2025. These calls for service include a fight, shooting, armed robbery, intoxicated individuals, overdoses, drug use, and thefts.

Furthermore, the Columbus Division of Fire has responded to the property at least eleven (11) times in 2025. Four (4) occasions were related to alcohol use and one (1) occasion included the administration of Narcan. A further review of Columbus Division of Fire records revealed that there are four (4) outstanding violations of Columbus Fire Code including an inoperable exit sign, exposed wires and improperly maintained electrical panels, inoperable equipment, and emergency exits obstructed.



A review of the records of the Columbus Public Health revealed at least seven (7) violations issued during a Food Inspection. These violations centered around unsanitary and improperly maintained facilities.
