[Surveyor's description of the premises follows]

Situated in the State of Ohio, County of Franklin, City of Columbus, Clinton Township, being in Quarter Township 4, Township 1, Range 18 West of the United States Military Lands, being a part of Lot 32 of Highway Park as recorded in Plat Book volume 14, page 9 (all document references are to the records of Franklin County unless otherwise stated), and being a **0.008 acre** parcel out of that tract known as Franklin County Auditor's **Parcel Number 010-061281** as conveyed to **Evans R. Smith and Roberta J. Smith** (hereafter referred to as "Grantor") by the instruments filed as **Deed Book volume 3666, page 779, Deed Book volume 3666, page 781, and Deed Book volume 3666, page 783**, and being more particularly described as follows:

Being a parcel of land lying on the left side of the existing centerline of right-of-way of Hudson Street (60' R/W – Public) and being more particularly described as follows:

**BEGINNING** at a point (referenced by a 5/8" iron pin found bearing North 74 degrees 38 minutes 51 seconds West a distance of 0.31 feet) at the southwest corner of the Grantor, the southwest corner of the said Lot 32, the southeast corner of Lot 31 of the said Highway Park, the southeast corner of that tract conveyed to James H. Stocks by the instrument filed as Official Record volume 10346, page D06, and on the existing northerly right-of-way line of Hudson Street, said point being 30.00 feet left of the centerline of right-of-way line of Hudson Street station 76+73.48, said point being the **TRUE POINT OF BEGINNING** of the parcel herein described;

Thence along the westerly line of the Grantor, the westerly line of the said Lot 32, the easterly line of the said Lot 31, and the easterly line of the said James H. Stocks tract, **North 03 degrees 33 minutes 14 seconds East for a distance of 15.00 feet** to a point being 45.00 feet left of the centerline of right-of-way of Hudson Street station 76+73.48;

Thence crossing through the lands of the Grantor, **South 59 degrees 01 minutes 43 seconds East for a distance of 17.37 feet** to a point being 37.00 feet left of the centerline of right-of-way of Hudson Street station 76+88.90;

Thence continuing through the lands of the Grantor, **South 86 degrees 26 minutes 46 seconds East for a distance of 25.09 feet** to a point on the easterly line of the Grantor, the easterly line of the said Lot 32 the westerly line of Lot 33 of the said Highway Park, and on the westerly line of that tract conveyed to Maria M. Ramirez Rivas by the instrument filed as Instrument Number 201704170051276, said point being 37.00 feet left of the centerline of right-of-way of Hudson Street station 77+13.98;

Thence along the said easterly line of the Grantor, the said easterly line of Lot 32, the said westerly line of Lot 33, and the said westerly line of the Maria M. Ramirez Rivas tract, **South 03 degrees 32 minutes 03 seconds West for a distance of 7.00 feet** to a point being at the southeast corner of the Grantor, the southeast corner of the said Lot 32, the southwest corner of the said Lot 33, the southwest corner of the said Maria M. Ramirez Rivas tract, and on the said existing northerly right-of-way line of Hudson Street, said point being 30.00 feet left of the centerline of right-of-way of Hudson Street station 77+13.98;

Thence along the Grantor's southerly line, the southerly line of the said Lot 32, and the said existing northerly right-of-way line of Hudson Street, **North 86 degrees 26 minutes 46 seconds West for a distance of 40.51 feet** to the **TRUE POINT OF BEGINNING** of the parcel herein described.

The above description contains a total area of **0.008 acres** (**0.000 acres** are located within the Present Road Occupied resulting in a net take of **0.008 acres**), all of which are located within Franklin County Auditor's **Parcel Number 010-061280**.

Prior instruments of record as of this writing recorded in **Deed Book volume 3666, page 779, Deed Book volume 3666, page 781, and Deed Book volume 3666, page 783**, in the records of Franklin County.

This description was prepared by Andrew T. Jordan, Ohio Registered Professional Surveyor number 8759, and is based on an actual field survey conducted by American Structurepoint Inc., and is true and correct to the best of my knowledge and belief.

The bearing for this description are based on Grid North as referenced to South 86 degrees 18 minutes 11 seconds East for the centerline of right-of-way of Hudson Street east of Interstate Route 71 (FRA-1-25.33) as referenced to the Ohio State Plane coordinate system (South Zone) and the North American Datum of 1983, as established utilizing a GPS survey and NGS OPUS solution.

The stations referenced herein are from the plans known as Hudson Street on file with City of Columbus, Ohio having "E" plan number 3575.
