The work under this contract consists of Janitorial Services for various Department of Public Utilities Facilities. The work to be performed under these specifications will be DOSD Janitorial Services at the Southerly Wastewater Treatment Plant, Jackson Pike Wastewater Treatment Plant, Compost Facility and the Sewer Maintenance Operations Center; DOW Janitorial Services at Griggs and Hoover Watershed facilities, Hap Cremean Water Plant, Parsons Ave Water Plant, Department of Public Utilities Offices, and various Division of Water Offices at 917 Dublin Rd and 3500 and 3568 Indianola Ave. Other Department sites may be added in the future. The work to be performed under these specifications will include cleaning services for not only office areas but also other industrial type areas such as store rooms, stock rooms, construction trailers, areas adjacent to garages, kitchens and break rooms. The Contractor shall furnish any and all cleaners, disinfectants, waxes, wax stripping materials, wastebasket liners, toilet seat liners, sanitation pad liners and any other products required to provide the cleaning services for DOSD. DOW will provide the majority of cleaning materials for the Contractor's use.

The performance of this project's activities to provide Janitorial Services for various Department of Public Utilities Facilities will provide orderly, properly maintained buildings for the use of the staff and public. This will prevent these facilities from deteriorating and requiring replacement that can produce an impact to the budget. No community outreach or environmental factors are considered for this project.

The contract will continue to provide Janitorial Services for various Department of Public Utilities Facilities.

Unanticipated renewal. The original contract allows for three (3) extension periods on a year to year basis. It is in the best interest of the Department to renew this contract for a final year (fourth renewal), as opposed to a rebid while the Department is in a period of transition in moving most offices to other buildings including 37 West Broad St. This fourth renewal is to provide the funding necessary for the payment of services to be provided through September 2027.

11. An explanation of why the work to be performed as part of the contract modification cannot be bid out. (Indicating the work to be a logical extension of the contract is not sufficient explanation.)

The same exact service is required as originally bid. No lower pricing/more attractive terms and conditions are anticipated at this time.

This contract will be funded incrementally with renewals on approximately an annual basis. Four contract renewals are anticipated at this time for DOSD and DOW Facilities. If other DPU Facilities are added, if unforeseen issues or difficulties are encountered that would require additional funding, a modification would be requested.
