The following information has been provided concerning the City of Columbus' 2013 – 2014 annual objection to the renewal of liquor permits. After reviewing the State of Ohio, Franklin County, and City of Columbus records regarding the above liquor permit establishment, the following information has been compiled with regard to a potential objection to the renewal of the permit issued by the State of Ohio.

The above listed liquor establishment has been issued a liquor permit from the Division of Liquor Control # 1401100. The permit holder received a D – 1 permit, a D – 2, a D – permit, a D – 3 permit, a D – 3 – A and a D – 6 This permit grants the permit holder the privilege to sell alcoholic beverages in the State of Ohio for on premises consumption as described by law.

An "Inquiry of Liquor Violations" was received from the State of Ohio, Division of Liquor Control. The "Inquiry of Liquor Violations" revealed that the permit holder has received the following violations:

Case Number 1 / May 31, 2013

The below listed violations have been assigned case #1249-13 by the liquor Control Commission. The Liquor Control Commission held a hearing on September 06, 2013, at which time the Liquor Control Commission sustained the below listed violations. The Commission ordered the permit holder to service a three (3) day suspension or to pay \$300 fine. The permit holder paid the fine on 12/12/2013.

1. INSANITARY CONDITIONS - ALCOHOLIC BEV NOT MAINTAINED IN POTABLE CONDITION

Information from the Division of Liquor Control further revealed that the Division of Liquor Control has received a request for safekeeping for this permit. The liquor establishment is temporarily closed.

A review of complaints received by the Columbus Division of Police – Vice Section revealed that the Vice Section has not received a complaint concerning the liquor establishment doing business as Charlie Bear located at 1562 N. High St., Columbus, Ohio 43201.

A review of Columbus Division of Police records revealed that the Division of Police have taken twenty-eight (28) police reports concerning incidents at the above listed liquor establishment during the year 2013.
