# FACT SHEET West 70 Logistics Land, LLC Bldg. #5 February 2022

## I. STATEMENT OF PURPOSE – ENTERPRISE ZONE & JOB CREATION

The Department of Development recommends an Enterprise Zone Tax Abatement of seventy-five (75%) for a period of ten (10) consecutive years on real property improvements for the purpose of constructing a new proactive industrial facility, and creating new employment opportunities for the residents of the City of Columbus.

### II. PROJECT HISTORY

West 70 Logistics Land, LLC is real estate holding company that is a subsidiary of TPA Ventures, LLC. TPA Ventures, LLC is a national real estate development company based in Atlanta, Georgia that has successfully acquired, developed and sold over \$20 billion in investments. They frequently partner with other operators in an investment or joint venture structure and have a history of over 250 proactive, build-to-suit and re-development projects to date.

West 70 Logistics Land, LLC is proposing to redevelop an obsolete industrial site at 800 Hilliard Rome Road with a total of 1,850,000 square feet of proactive industrial development. For Building #5 of this new development, West 70 Logistics Land, LLC proposes to invest a total project cost of approximately \$72,900,000 which includes \$64,700,000 in real property improvements, \$2,100,000 machinery and equipment, \$800,000 in furniture and fixtures, and \$5,300,000 in leasehold improvements to construct an approximately 300,000 square-foot proactive Class A industrial building at 800 Hilliard Rome Road, Columbus, Ohio 43228, parcel numbers 246-303775 and 470-296106 (the "**Project Site**"). The company anticipates that the development of the proposed project will lead to the creation of 38 net new full-time permanent positions with an estimated new annual payroll of approximately \$1,620,000 at the **Project Site**, and since it is a proactive industrial development project, may lead to the retention or relocation of an unknown number of positions from within the City of Columbus or surrounding communities.

West 70 Logistics Land, LLC is requesting an Enterprise Zone property tax abatement of seventy-five percent (75%) for a period of ten (10) consecutive years on real property improvements to assist in the construction of this project.

Real property improvements are expected to begin as soon as June 2022 with a scheduled time of completion of December 2023, contingent upon Columbus City Council approval of the Updated as of Thursday, January 27 2022

recommended tax incentive and the successful expansion of the City of Columbus Enterprise Zone. (Zone 023), which would include the proposed parcel comprising the Project Site.

# V. EMPLOYMENT

The project will create 38 net new full-time permanent office positions with an estimated annual payroll of approximately \$1,620,000.

#### VIII. TAX BENEFIT

The recommended 75%/10-year Enterprise Zone property tax abatement could yield a tax savings of approximately \$15,327,040 for West 70 Logistics Land LLC Building #5 over the incentive term of ten (10) years.

Columbus City School District is estimated to receive an additional \$1,490,740 over the term of the abatement and approximately \$7,453,385 over a 20-year period, as a result of the construction project.

The first ten years of total taxes for the Library, County, Township, Schools and City net of the abatement equals a total of approximately \$2,589,887.

100% for the next ten years is \$10,359,546 plus the 2,589,887 from the first ten years equals a total for 20 years of approximately \$12,949,433.

South-Western City School District is estimated to receive an additional \$1,443,710 over the term of the abatement and approximately \$7,219,960 over a 20-year period, as a result of the construction project.

The first ten years of total taxes for the Library, County, Township, Schools and City net of the abatement equals a total of approximately \$2,519,128.

100% for the next ten years is \$10,076,512 plus the \$2,519,128 from the first ten years equals a total for 20 years of approximately \$12,595,640.
