Situated in the State of Ohio, County of Franklin, City of Columbus, located in Farm Lot 18 of Flavel Tuller's Survey of Section 1, Township 2 North, Range 19 West, United States Military Lands, as recorded in Plat Book 3, Page 60, and being a part of Lot 1014 of the Olde Sawmill Section Nine Subdivision as recorded in Plat Book 60, Page 64, as conveyed to Dale Warren Leach and Claudia Jean Leach by deed of record in Instrument Number 199811020279031, all records of the Recorder's Office, Franklin County, Ohio, and being more particularly described as follows:

Being a parcel of land located on the left side of the Plat of the Centerline of Right-of-Way of FRA-C.R. 61-1.10, as recorded in Plat Book____, Page____;

Beginning at a 5/8" iron pipe found marking the southeast corner of said Lot 1014, being 40.00 feet left of Hard Road centerline station 136+75.18;

Thence North 87 degrees 39 minutes 05 seconds West, a distance of 117.22 feet along the southerly line said Lot 1014, and along the existing northerly Right-of-Way line of Hard Road, to a 5/8" iron pipe found marking the southwest corner of said Lot 1014, being 40.00 feet left of station 135+57.96;

Thence North 02 degrees 20 minutes 55 seconds East, a distance of 5.00 feet along the westerly line of said Lot 1014 to a point being 45.00 feet left of station 135+57.96;

Thence South 87 degrees 39 minutes 05 seconds East, a distance of 118.15 feet across said Lot 1014, to a point in the easterly line of said Lot 1014, being 45.00 feet left of station 136+76.10;

Thence South 12 degrees 47 minutes 48 seconds West, a distance of 5.08 feet along the easterly line of said Lot 1014 to the **Point of Beginning**, containing 0.014 acres, more or less;

The bearing datum of the afore-described parcel is based upon the Ohio State Plane Coordinate System, South Zone, NAD 1983 (1986 Adjustment), as measured using G.P.S. methods through the Franklin County Engineer's stations FRANK 74, FRANK 174, FCGS 7772, FCGS 6651, FCGS 2232, and FRANK 2218 RESET.
