This memorandum is a recommendation for construction contractor selection and processing the construction legislation for the Pedestrian Safety Improvements - Quick to Construct Project 2 (Grandview Ave., Henderson Rd., and Weinland Park) project.

Project Scope:

The work for this project consists of: sidewalk construction on both sides of Grandview Avenue between 5th Avenue and King Avenue, on the south side of Henderson Road between Kenny Road and Reed Road, and on 6th Avenue between 5th Street and 6th Street. This project will also install a curb extension and ramps on 6th Avenue at 5th Street; curb extension, ramps and landscaping at the intersections of Indianola Avenue and 5th Avenue, and Indianola Avenue and 9th Avenue.

<u>Fiscal Impact:</u> Source of funds is 2013 Department of Public Service bonds. The low bid exceeded the amount budgeted. The plan to cover the difference is to adjust the spend down plan and use unencumbered 2012 funds.
