BEGINNING at the southeast corner of said Lot 20, said point being the intersection of the west right of way line of Ann Street (40' public right of way) with the north right of way line of an alley (20' public right of way), 20.00 feet left of centerline Station 208+72.68;

thence along the south line of said Lot 20 and the north line of said alley, North eighty-six degrees nine minutes forty-one seconds West (N86°09'41"W), for three and 37/100 feet (3.37') to a point, 23.37 feet left of centerline Station 208+72.69;
