

**RIGHT OF WAY PARCEL
PARCEL 31-WD
0.0011 ACRE TRACT (50.0 S.F.)
EXHIBIT "A"**

Situate in the City of Columbus, County of Franklin, State of Ohio, Virginia Military Survey No. 971, being part of Reserve "B" of Wilshire Heights Subdivision as recorded in Plat Book 15, Page 32 and conveyed to Jack W. Fry by deed recorded in Instrument No. 200804220061522 (all references to deeds, microfiche, plats, surveys, etc. refer to the records of the Franklin County Recorder's Office, unless noted otherwise) and being more particularly bounded and described as follows:

BEGINNING at a 3/4" iron pipe found at the southwest corner of said Reserve "B", being at the intersection of the north right of way line of Mound Street (50' public right of way, originally dedicated as Dartmoor Road, see City of Columbus Ordinance No. 196-43) with the east right of way line of Warren Avenue (50' public right of way);

thence along the west line of said Reserve "B" and the east right of way line of said Warren Avenue, North eight degrees fourteen minutes one second East (N08°14'01"E) for ten and 00/100 feet (10.00') to an iron pin set;

thence leaving said lines across said Reserve "B", South thirty-six degrees forty-five minutes fifty-nine seconds East (S36°45'59"E) for fourteen and 14/100 feet (14.14') to an iron pin set on the south line of said Reserve "B" and the north right of way line of said Mound Street;

thence along said lines, North eighty-one degrees forty-five minutes fifty-nine seconds West (N81°45'59"W) for ten and 00/100 feet (10.00') to the **POINT OF BEGINNING**, containing 0.0011 acres (50.0 S.F.), more or less, subject however to all covenants, conditions, restrictions, reservations and easements contained in any instrument of record pertaining to the above described tract of land.

Iron pins set are 5/8" rebar, 30" in length, with a plastic plug placed on top inscribed with the name "WOOLPERT INC", unless otherwise noted. All monuments found are in good condition unless otherwise noted.

Bearings are based upon the Ohio State Plane Coordinate System, South Zone, NAD83 (2007). Said bearings originated from said coordinate system by GPS observations and observations of Franklin County Survey Monuments 5/14 and COC 1-83. The portion of the centerline of Mound Street stretching west to east from Binns Boulevard to Ogden Avenue, having a bearing of S81°45'59"E, is designated the "Basis of Bearing" for this description.

This description was prepared under the direction of Cody Schneider, Ohio Registered Surveyor No. 8670, of Woolpert Inc., and is based on a field survey performed during February and March, 2013, as well as February, 2016.
