ARTICLES OF INCORPORATION OF MORSE ROAD SPECIAL IMPROVEMENT DISTRICT OF COLUMBUS, INC.

EXHIBIT A

THIRD:	The purpose for which the Corporation is formed shall be:
<u>PURPOSE</u>	To govern the Morse Road Special Improvement District of Columbus, a special improvement district (the "District") created pursuant to Ohio Revised Code ("ORC") Chapter 1710.
	To engage in any lawful act, activity or business not contrary to and for which a nonprofit corporation may be formed under the laws of the State of Ohio.
	To have and exercise all powers, rights and privileges conferred by the laws of Ohio on nonprofit corporations, including, but not limited to, buying, leasing or otherwise acquiring and holding, using or otherwise enjoying and selling, leasing or otherwise disposing of any interest in any property, real or personal, of whatever nature and wheresoever situated, and buying and selling stocks, bonds, or any other security of any issuer as the Corporation by action of its Board may, at any time and from time to time, deem advisable.
FOURTH: <u>RESTRICTIONS</u>	No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its directors, officers or other private person, except that the Corporation shall be authorized to pay reasonable compensation for services rendered, to make payments in furtherance of the purposes of the Corporation and to make distributions to its members as authorized by ORC Chapter 1702, including any distribution upon dissolution of the Corporation.
SIXTH: <u>MEMBERS</u>	The members of the Corporation shall be those persons or organizations described in the Code of Regulations. The members of the Corporation may be a corporation, whether profit or nonprofit, provided such members otherwise qualify as a member.
SEVENTH: BOARD OF DIRECTORS	The Corporation shall be controlled and managed under the direction of a Board of Directors ("Board").
EIGHTH: <u>TERRITORY</u>	The territory within the District shall be generally described as that portion of the City of Columbus, Ohio, which is located within the following general area:
	Assessable properties on Morse Road or its service roads, and nearby related properties, from Indianola Avenue in the west to

Cleveland Avenue in the east, a distance of approximately 2.6 miles. The common denominator of these properties is that they are in the general vicinity of the streetscape and landscape improvements along Morse Road and share a common interest in having the area of Morse Road kept clean and well maintained.

NINTH: The mission of the District is to enhance the value of properties within the District by keeping the area of the streetscape and **REASONS FOR** landscape improvements along Morse Road clean and well maintained, and by carrying out such other limited improvements and/or services in and for the benefit of the District as the Board of Directors may determine and funds may allow.

> The District will be authorized to provide services and improvements pursuant to ORC Chapter 1702 that will benefit property within the boundaries of the District. The City of Columbus will be authorized to levy a special assessment on property within the District to pay for such services and improvements, based on the benefits conferred by those services and improvements.

> No person shall be disqualified from being a director of the Corporation because he or she is or may be a party to, and no director of the Corporation shall be disqualified from entering into, any contract or other transaction to which the Corporation is or may be a party.

> No contract, action or other transaction shall be void or voidable for reason that any director or officer or other agent of the Corporation is a party thereto, or otherwise has any direct or indirect interest in such contract, action or transaction or in any other party thereto, or for reason that any interested director or officer or other agent of the Corporation authorizes or participates in authorization of such contract, action or transaction, provided that:

> The material facts as to such interest and as to the contract, action or transaction are disclosed or are otherwise known to the Board or applicable committee of directors at the time the contract, action or

	transaction is authorized and the directors or the members of the committee, in good faith reasonably justified by the facts, authorize the contract, action or transaction by at least a majority vote of the disinterested directors or disinterested members of the committee, even though such disinterested directors or members are less than a quorum; or
	The material facts as to such interest and as to the contract, action or transaction are disclosed or are otherwise known to the member at the time the contract, action or transaction is authorized and the member authorizes the contract, action or transaction; or the contract, action or transaction (i) is not less favorable to the Corporation than an arm's length contract, action or transaction in which no director or officer or other agent of the Corporation has any interest or (ii) is otherwise fair to the Corporation as of the time it is authorized.
	Any interested director may be counted in determining the presence of a quorum at any meeting of the Board or any committee thereof which authorizes the contract, action or transaction.
ELEVENTH: DISSOLUTION	Upon the dissolution of the Corporation, any assets remaining shall be conveyed to any person or organization as shall be selected by the affirmative vote of a majority of the Board.
TWELFTH: <u>AMENDMENT</u>	Any provision of these Articles of Incorporation may be amended only (a) by the affirmative vote of a majority of the members of the Corporation at any meeting at which a quorum is present, and (b) after receipt of approval of such amendment by resolution of the legislative authority of the City of Columbus, and (c) upon filing the approved amendment and resolution with the Ohio Secretary of State; provided that such amendment shall be consistent with the applicable provisions of ORC Chapters 1702 and 1710.
