For logistical purposes, it has been determined that establishing one contract for services with Woolpert and one contract for software directly with Cityworks is the best path forward. The software contract is an annual Enterprise licensing agreement that includes cloud-hosting services and will need to renew each year. The yearly software renewal legislation will be processed in October.

This modification legislation is for an additional 150 licenses. These additional licenses will be prorated from May 2025-October 2025. There are no direct services associated with the contract. Those are going to be performed with the Woolpert contract.
