Situated in the State of Ohio, County of Franklin, City of Columbus located in Quarter Township 1, Township 1, Range 19 (USML) and being a part of a 16.665 acre tract of land conveyed to AE-Fox & Hounds Associates, L.P. by deed of record in I.N. 199911180288597 of the Recorders office, Franklin County, Ohio and being more particularly described as follows:

Beginning at a point, said point being 40.00 feet right of station 82+45.00, said point being the point of beginning;

Thence N 03°17'54" E a distance of 135.86 feet to a point, said point being 40.00 feet right of station 83+80.86;

Thence N 03°17'54" E a distance of 104.14 feet to a point, said point being 40.00 feet right of station 84+85.00;

Thence S 86°42'06" E a distance of 5.00 feet to a point, said point being 45.00 feet right of station 84+85.00;

Thence S 03°17'54" W a distance of 104.14 feet to a point, said point being 45.00 feet right of station 83+80.86;

Thence S 86°42'08" E a distance of 5.00 feet to a point, said point being 50.00 feet right of station 83+80.86;

Thence S 03°17'54" W a distance of 135.86 feet to a point, said point being 50.00 feet right of station 82+45.00;

Thence N 86°42'06" W a distance of 10.00 feet to the point of beginning.

The above described area is contained with the Franklin County Auditor's Parcel Number 010-129873 (0.031 acres) and 010-129874 (0.012 acres), within said boundary is 0.043 acres, more or less.

This description and survey was prepared and reviewed on January 24, 2015, by Joseph S. Bolzenius.

The centerline described in this document refers to the centerline of construction as shown on the City of Columbus roadway plan "Kenny Road Sidewalk Improvements (3113 Dr. E)".

The basis of bearings in this description area based on the State Plane Coordinate System, Ohio South Zone, NAD83 (NSRS 2011), which were determined by GPS observations conducted by the Patrick Engineering survey staff. The Columbus, Mount Vernon and McConnelville CORS stations were used, which establishes a bearing along the centerline of Kenny Road to be N 3°17'54"E between Henderson Road and station 86+01.50 (just south of Weybridge Road).
