LEGAL DESCRIPTION OF A 0.023 ACRE ELECTRIC EASEMENT

COMMENCING FOR REFERENCE at a 3/4" iron pipe found at the Grantor's northeasterly corner and on the southerly right of way line of a service road (45' wide) located on the south side of and adjacent to Morse Road, the said pipe also being at the northwesterly corner of a 8.935 acre parcel conveyed to Columbus-Morse Rd. BNK Investors, L.L.C. by the instrument filed as Instrument Number 199812220329592;

Thence along the Grantor's easterly line and the westerly line of the said parcel conveyed to Columbus-Morse Rd. BNK Investors, L.L.C., South 03 degrees 32 minutes 38 seconds West for a distance of 174.92 feet to a point being the TRUE POINT OF BEGINNING of the parcel herein described.

Thence continuing along the Grantor's easterly line and the westerly line of the said parcel conveyed to Columbus-Morse Rd. Bnk Investors, L.L.C., South 03 degrees 32 minutes 38 seconds West for a distance of 24.04 feet to a point;

Thence crossing through the lands of the Grantor the following six (6) courses:

South 28 degrees 07 minutes 33 seconds West for a distance of 58.87 feet to a point;

North 61 degrees 52 minutes 27 seconds West for a distance of 10.00 feet to a point;

North 20 degrees 01 minutes 17 seconds West for a distance of 27.43 feet to a point;

North 69 degrees 58 minutes 43 seconds East for a distance of 14.00 feet to a point;

South 20 degrees 01 minutes 17 seconds East for a distance of 14.89 feet to a point;

North 28 degrees 07 minutes 33 seconds East for a distance of 61.94 feet to the TRUE POINT OF BEGINNING, containing 0.023 acres, more or less, of which 0.000 acres are in the present road occupied.
