This proposal is for furnishing labor, material, equipment, and incidentals required for piping and accessories on the east and west end of the 48" diameter head pipes at the Hap Cremean Water plant.

The east end; The header shall be removed at the existing flanges approximately 6" from the east wall to the venturi. Reusing the existing 48" flange at the wall. Installing a new 48"X24" fabricated "T", new 48" dresser coupling and ending at the venturi with two 48" mating flanges. This shall include a new 24" man way and 6" drain line on bottom of the pipe.

The west end; Remove the existing 48" pipe starting approximately 6" to 12" from the south wall to the south end of the venturi. Reinstall new 48" pipe starting at the south wall with two 48" mating flanges and 48"X24" fabricated "T", 48" dresser coupling and a new saddle per detailed drawings by your engineers. Ending with two 48" mating flanges on the south end of the venturi. This will be accomplished by relocating the venturi north approximately 60" along with all the accessories.
