Situated in the State of Ohio, County of Franklin, City of Columbus, being located in Quarter Township 4, Township 2, Range 18 of the United States Military Lands, lying within a 0.657-acre parcel conveyed to Jaffar Properties, LLC, an Ohio Limited Liability Company of record in Instrument Number 201007080085489 and being more particularly described as follows:

Being a parcel of land lying on the left side of the centerline of a survey made for project FRA-161-11.73, made by the Ohio Department of Transportation, and being located within the following described points in the boundary thereof:

**Beginning** at the intersection of the westerly existing right-of-way line of Tamarack Boulevard with the southerly property line of said 0.657-acre tract, said point, being 30.00' left of centerline Station 56+53.14;

Thence along the southerly property line of said 0.657-acre tract, N 86°44'41" W a distance of 18.77' to a point, being 48.78' left of centerline Station 56+53.14;

Thence leaving the said southerly property line and passing through the said 0.657-acre tract the following seven (7) courses and distances:

6. With a curve to the left, having a radius of 373.50', a delta angle of 08°54'11", an arc length of 58.04', and subtended by a chord bearing S 01°11'46" E, a distance of 57.98' to a pin set on the existing right-of-way, being 30.00' left of Station 56+80.96;

Thence along the existing westerly right-of-way of Tamarack Blvd., S 03°15'19" W, a distance of 27.82 to the **Point of Beginning**, containing 0.053 acres, more or less.

The above-described area is within Auditors Parcel No. 010-012439.

Subject to all legal rights-of-way and/or easements, if any, of previous record.

Bearings are based on the centerline of State Route 161 (Dublin-Granville Road) as having a bearing of S 87°00'00" E, established from GPS observations, referencing the State Plane Coordinate System, Ohio South Zone, NAD 83 (2011).

All pin set are 5/8-inch diameter steel rebar, 30-inches in length, with a yellow plastic cap inscribed with "Dynotec, Inc.".
